

## ■ General

Kreidezeit Alcohol (ethyl alcohol, spirit) is a fermentation alcohol. It is obtained by fermenting plant material containing sugar or starch through certain yeasts (analogous to beer/wine production) and subsequent distillation. Distillation tax is levied on pure alcohol as a beverage. For tax reasons, so-called denaturants are therefore added to it for technical applications, which make it inedible or cause immediate vomiting if swallowed.

## ■ Usage

For diluting alcohol dissolved Kreidezeit products such as Shellac Sealing Primer. For cleaning tools that have been soiled with these products.

For stain removal and degreasing of surfaces. For dissolving alcohol-soluble natural resins such as shellac and copal.

## ■ Composition

Ethyl alcohol (96 %), isopropanol, Bitrex, methyl ethyl ketone

## ■ Storage

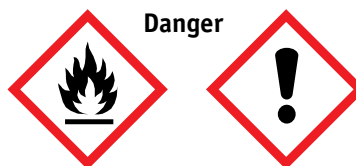
Shelf life approx. 2 years if unopened. Always keep opened containers hermetically closed.

## ■ Warning

## ■ Disposing Leftover Product

Do not discharge product residues into the waste water, but keep them airtightly sealed and use them later. Put completely emptied containers into the collection of recyclables. The current official regulations for the disposal of paint and paint residues must be observed.

- H 225: Highly flammable liquid and vapour.

## ■ Precautionary statements
